# GS1 Malaysia Berhad Membership & License Agreement

## TERMS & CONDITIONS

The GS1 Standards and Keys cover product item identification using allocated numbers, barcode symbol generation & printing, electronic communication of product event data and trusted product data repositories, in trade and services. The GS1 Standards and Keys are used by more than 150 countries worldwide and in Malaysia is under the governance of **GS1 Malaysia Berhad** (1201396-K)

### A) Allocation of Subscriber Number

1. Upon receipt of the completed registration form together with the documents required and applicable fees, each subscriber under the current prevailing membership categories will be allocated a GS1 Company Prefix Number (GCP) to be used to form Global Trade Item Number (GTIN) 13-digit barcode numbers.
2. Subscribers who request for more than one GS1 Company Prefix (GCP) will need to apply for an Additional Membership. Each Additional Membership will come with a single GS1 Company Prefix (GCP) from the available membership categories at the time of the application. The allocation of Additional Membership will be chargeable according to the prevailing Additional Membership Fees at the time of application. The Subscriber's renewal subscription fees will be increased by an amount equal to the price of each additional GS1 Company Prefix successfully allocated.
3. UPC Licenses and GTIN-8 barcode numbers are alternative GS1 identifiers that are available only upon request by active GS1 Malaysia GTIN Subscribers. UPCs are 12-digit identifiers for products traded in the US or Canada, while GTIN-8 are generally used on small form factor products. UPC Licenses can generate 1,000 UPC codes. GTIN-8 are issued individually. A subscriber member's subscription renewal fees are increased by an amount equal to the price of each UPC license or individual GTIN-8 number requested.

### B) Fees

1. Any company who wishes to be a subscriber member of GS1 Malaysia Berhad shall complete the Membership Application and submit it together with all appropriate fees and required documents through one of the below methods:

2. **Payment of fees** is made to GS1 Malaysia's **business account, account No.:** 514208-626-707 (Maybank). **Documented proof of payment** must be **submitted** to GS1 Malaysia to **validate** the payment.
3. **Renewal fees** are based on the company's present issued capital. You can find the fee amount in the GS1 Sub Fee Guides. Should the company's issued capital be changed during its course as a subscriber of GS1 Malaysia Berhad, their renewal fees will also be adjusted based on the latest issued capital.
4. New subscribers are **required** to pay the fees listed in the GS1 Sub Fee Guides under **Grand Total**, tied to the **month of joining**.
5. All new GS1 Malaysia Berhad subscribers are **required** to pay a **Security Deposit**. The deposit is held in trust but can be used to offset a subscriber's outstanding fees if the payments are in arrears for a period of three months after the date of invoice.
6. GS1 Malaysia Berhad reserves the right to revise the fees and benefits stipulated for our optional services such as Verified by GS1 & GAC Support & Services (VbG & GACSS) from time to time as deemed necessary.
7. Upon receiving the approval letter, all deposited fees (save for the security deposit) are non-refundable and non-transferable.
8. GS1 Malaysia Financial Year starts from **July 1**. GS1 reserves the right to charge interest of **8% per annum** on the total sum billed from the expiration of one month from the billing date (i.e. by 1<sup>st</sup> August). A **RM250.00 late charge** will be charged for every unpaid invoice. Subscribers who do not pay their renewal fees **within a period of three months** from July 1 until end September shall have their allocated GS1 License, all accompanying GS1 identification keys and other GS1 licenses **suspended**. This means that they can no longer use any GS1 barcode keys, GS1 barcode symbols and other authorised GS1 data carriers, nor can their product records be referenced from GS1's trusted data repositories. This suspension shall be advised to local regulators, retailers, marketplaces, and related users including other GS1 Member Organisations around the world, not to accept products bearing withdrawn GS1 Licensed numbers or identifiers.
9. **10% of the total paid Fees** will be deducted upon written request by subscriber to **cancel the application process part-way**.
10. **Regarding Invoices** – **softcopies** of the renewal invoice are issued **3 months** before the end of each financial year (from March onwards) and sent to the **registered email address**. **Hardcopies** are only issued **upon request**.

### C) Documentation

1. The documents required to be submitted together with the application are as follows:
  - For Sole-Proprietor/ Partnership – **Business Registration Certificate / SSM**
  - For companies registered with the Companies Commission of Malaysia (formerly known as Registrar of Companies):
    - **Certificate of Incorporation / Section 14**
    - **Latest Form of Annual Returns or Latest Form 24** (only if the company is incorporated less than 24 months)
  - For companies not registered in Malaysia (foreign companies)
    - **Business Registration** (must list at minimum the company name & date of incorporation. Must have official identifier.)
    - **Latest Annual Returns** (must contain total amount of issued capital for GS1 subscription fee calculation)

### D) Termination

#### i) Termination by GS1 Malaysia Berhad

1. Subscribers that use any GS1 identification keys, GS1-approved barcode symbols and other authorised GS1 data carriers must maintain their membership by paying their subscription renewal fees when it becomes due.
2. GS1 Malaysia Berhad reserves the right to terminate the membership herein by giving 3 months' notice to the subscriber. GS1 Malaysia Berhad reserves the right to terminate a subscriber's membership immediately (after notice is given) if the subscriber:
  - a. Fails to pay their membership subscription fees by the due date.
  - b. Is declared bankrupt, is undergoing liquidation, has appointed a receiver or statutory manager, or the company is winding up for purposes other than for reconstruction.



c. Commits any breach of these Terms & Conditions or abuses the GS1 Standards and Keys in any way.

#### **ii) Termination by Subscribers**

1. Subscribers who wish to terminate their membership must inform GS1 Malaysia Berhad in writing with official company letter head or company resolution documentation. If no such written document is received, it will be deemed that the subscribers wish to continue their membership and they will be billed accordingly every year.
2. Subscribers who have paid **advance renewal fees** but wish to terminate **before the end of the advance renewal period**; such termination requests are subject to review by GS1 Management.
3. Members who have multiple GS1 Membership Licenses: each license can be **terminated individually**.
4. Members who terminate their membership less than **12 months after registration** or **3 months after the beginning of a financial year (every July 1<sup>st</sup>)** are subjected to pay for 1 full year subscription fee for the current financial year.
5. Termination cannot proceed if there are any products being sold / traded on the market bearing the terminated GS1 barcode keys.
6. GS1 Malaysia Berhad will contact our **auditors** to ascertain whether any products bearing GS1 barcode keys issued to the subscriber are in the marketplace, supply chain or otherwise in use by the subscriber at the time of, or after, termination of membership. Proof that a product is still sold can be provided back to the member at **RM 1,050.00 per image**.
7. GS1 Malaysia Berhad reserves the right to **reassign the GS1 Company Prefix(s) to another company** after termination.
8. Until the termination is confirmed the **account will remain current** and all invoices **remain due for payment**. If products bearing GS1 barcode keys issued to the subscriber **are in circulation** at the time of termination of the membership, the subscriber will remain liable for a fee equivalent to the Renewal Fee for the period that those products remain in circulation.
9. For the avoidance of doubt, termination does not relieve the subscriber from its obligations regarding payment of any outstanding fees for this subscription membership and licence agreement.
10. The Security Deposit will be refunded upon confirmation of termination (3 months from the date of written request received) and after such fee as stated in item (6) above has been fully settled and after GS1 Malaysia Berhad has ascertained NO products bearing GS1 barcode keys issued to the subscriber still remain in marketplaces, supply chains or otherwise in use by the subscriber at the time of, or after, termination of membership.
11. If the subscriber fails to make full settlement of the outstanding amounts due to GS1 Malaysia Berhad **within thirty (30) days** from the date of the confirmation of termination, GS1 Malaysia Berhad shall be allowed to deduct the subscriber's outstanding amount from their Security Deposit before refunding the excess (if any) to the subscriber.
12. Any use of the GS1 Standards and Keys after termination of membership **is strictly forbidden**. The subscriber must immediately cease usage of the GS1 ID keys, GS1 barcode symbols and other authorised GS1 data carriers or be held liable for any damages which might be suffered by GS1 Malaysia Berhad or any of its subscribers. Furthermore, upon termination (at GS1 Malaysia Berhad discretion) of the subscription herein, GS1 Malaysia Berhad is hereby authorised to give notice to any party or parties in or outside of Malaysia of such termination of the subscriber from the use of the GS1 Standards and Keys and/or publish the termination of said subscriber's GS1 membership in any manner as deemed fit, and the subscriber shall not take action against GS1 Malaysia Berhad in response to such notification or publication.
13. **Reinstatement** of a GS1 Malaysia Berhad membership & accompanying licenses will be subjected to **reinstatement fees**, as well as all relevant fees as specified in the GS1 Sub Fee Guide based on the month of rejoining.

#### **E) General Provisions**

1. GS1 Malaysia Berhad grants each subscriber a non-exclusive, non-transferable license to use the GS1 barcode keys, GS1 barcode symbols and other authorised GS1 data carriers solely for the purposes as stated in these Terms and Conditions. Subscribers are **NOT allowed to assign, give, rent, lease, or sell** any GS1 barcode keys, GS1 barcode symbols and other authorised GS1 data carriers issued by GS1 Malaysia Berhad to another company.
