## **Disclaimer:**

- 1. The Grand Total fee paid upfront is not recurring.
- 2. GS1 Financial Year is from 1 July current year to 30 June next year.
- 3. The only recurring fee is the renewal fee and VbG-PDSS.
- 4. Renewal of your next applicable subscription fees will be every 2 years or Current Year + 1 Year in Advance.
  - a. Your GS1 membership license renewal cycle is calculated to cover a product under the Product Life Cycle
- 5. The VbG-PDSS (RM 380.00) is our support & services package required for access into GS1 data repositories. It is subscription-based and maintained separately from the main Membership License.
- 6. The Barcode Number Generation Service is an optional service for GS1 subscribers at RM 100.00 for 10 barcode numbers.
- 7. The pro-rated fee is the partial annual fee based on the join month until June.
- 8. The Security Deposit is the equivalent of one and a half year's annual fee. It is:
  - i. Used to offset the GS1 Malaysia Berhad subscriber's annual fees if the payments are in arrears for a period of three months after the date of invoice.
  - ii. Refunded upon confirmation of termination, unless used to offset outstanding fees.
- 9. The Small Block Membership License is meant for promotional products, festive-run products, seasonal run products, impulsive or limited-run products, ideas, or vouchers ONLY. It provides limited & different barcode numbers from that of a Standard Membership License and is NOT SUITED for long-term use on permanent products or on your main product catalogue.
- 10. During your application you must acknowledge and send back the Small Block Membership Acknowledgement Letter.
- 11. Should you have insufficient barcode numbers, Additional Membership Licenses are available. Terms and Conditions apply.
- 12. Members that want to terminate their membership less than 12 months after successful registration are subjected to pay for 1 full year's subscription fee.
