Disclaimer:

- 1. The Annual Fee is linked to your company's issued capital i.e., the total value (in RM) of company shares offered to shareholders of your company. Can be found in Section 14/Super Form or Form 24. Sole Proprietor or Partnerships are automatically in the "2.5 million and below" category.
- 2. The Grand Total fee paid upfront is not recurring.
- 3. GS1 Financial Year is from 1 July current year to 30 June next year.
- 4. The only recurring fee is the annual fee and VbG-PDSS.
- 5. The Barcode Number Generation Service is an optional service for GS1 subscribers:
 - a. 250 barcode numbers for RM 250.00
 - b. 1,000 barcode numbers for RM 500.00
 - c. Note: Generated Numbers are from your subscribed license(s) only!
- 6. The pro-rated fee is the partial annual fee based on the join month until June.
- 7. The Security Deposit is the equivalent of one and a half year's annual fee, and it will be:
 - i. Used to offset the GS1 Malaysia Berhad subscriber's annual fees if the payments are in arrears for a period of three months after the date of invoice.
 - ii. Be refunded upon confirmation of termination, if not already used to offset the annual fee.
- 8. The VbG-PDSS is our support & services package required for access into GS1 data repositories.
- 9. Members that would like to terminate their membership less than 12 months after registration are subjected to pay for the 1 full year subscription fee for the current financial year.
