Important Information:

1. Renewal Fee

• This fee is **due every year on 1st July**, after your initial subscription period ends.

2. Join Month – Financial Year: 1 July to 30 June.

- Your Join Month affects your first year's subscription fees.
- 3. Registration Fee A one-time fee paid when you first register as a GS1 member.

4. Pro-Rate Fee

• If you join mid-year, your first year's subscription fee will be prorated based on the **remaining months** in the current financial year.

5. 2-Year Advance Payment

- The subscription fees for the **next 2 years are included** and paid in advance as part of your membership application.
- 6. Verified by GS1 Product Databank Support & Services, VbG-PDSS (RM380.00) This service is **important** for your GS1 Membership:
 - Manages your product and company data, provided by you, to help your trading partners and consumers **authenticate** your brand and products.
 - This service is **renewed annually** and is maintained **separately from your main Membership**.
 - Comes with **5 complimentary Barcode Symbol Verification Service vouchers** (**valid** for **1 year** from registration).

7. Security Deposit – Equal to 1.5 times your annual renewal fees.

- Used to offset the GS1 Malaysia Berhad subscriber's annual fees if payments are in arrears over a period of three months after the date of invoice.
- Can be refunded upon confirmation of termination, unless used to offset fees.
- 8. Grand Total The total one-time amount payable for your membership and services.
- 9. Security Deposit- Equal to 1.5 times your annual renewal fees is held in trust.

Additional Notes:

- 1. GLN Numbers are used to identify legal entities, locations and assets (physical, digital, stationary or mobile), but **cannot** be used to identify products or logistical items.
- 2. If you decide to cancel your membership **within 12 months of joining**, you will still need to **pay for full year of subscription fees**.
